


GRANT TO THE FISHER CENTER FOR ALZHEIMER'S RESEARCH AT THE ROCKEFELLER UNIVERSITY FOR NEUROLOGICAL RESEARCH INTO THE CAUSES OF ALZHEIMER'S AND POTENTIAL NEW PHARMACOLOGICAL TREATMENT OPTIONS. THE LAB IS UNDER THE DIRECTION OF NOBEL LAUREATE DR. PAUL GREENGARD WHO HEADS A TEAM OF 50 SCIENTISTS. HIS SEMINAL FINDINGS HAVE BEEN THE BASIS OF MANY OF TODAY'S ALZHEIMER'S INVESTIGATIONS WORLDWIDE.
